A. MODE OF MEETING

The 58th AGM will be conducted entirely through live streaming using the remote participation and voting (“**RPV**”) facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. (“**Tricor**”) via TIIH Online website at <https://tiih.online>. Shareholders are to participate, speak (via real time submission of typed texts only) and vote remotely using the RPV facilities.

Pursuant to Section 327(2) of the Companies Act 2016, the Chairman shall be present at the Broadcast Venue to chair the 58th AGM. Shareholders will not be allowed to attend the 58th AGM in person at the Broadcast Venue on the day of the Meeting.

B. APPOINTMENT OF PROXY/AUTHORISED REPRESENTATIVE/ATTORNEY

If you wish to appoint proxy to participate and vote at the 58th AGM on your behalf, you must ensure that the duly executed Proxy Form is deposited either in a hard copy form at Tricor’s office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or at its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or by electronic means via TIIH Online website at <https://tiih.online> no later than **Sunday, 27 October 2024 at 11.00 a.m.** (**Please refer to the Procedures in Section D below**).

Authorised representative of corporate member must deposit the ORIGINAL Certificate of Appointment of Authorised Representative at Tricor’s office on or before the time appointed for holding the 58th AGM for the appointment to be valid for the purposes of attending the 58th AGM.

For an attorney appointed via a Power of Attorney, the Power of Attorney or a notarially certified copy of such Power of Attorney must be deposited at Tricor’s office at the address above or by electronic means via TIIH Online website at <https://tiih.online> not later than **Sunday, 27 October 2024 at 11.00 a.m.** for the appointment to be valid for the purposes of attending the 58th AGM.

C. PROCEDURES FOR USING THE RPV FACILITIES

Only shareholders whose name appears in the Record of Depositors as at **21 October 2024** shall be entitled to participate, speak and vote at the 58th AGM or to appoint proxy, authorised representative or attorney, as the case maybe, to participate, speak and vote on their behalf at the 58th AGM.

For shareholder/proxy/authorised representative/attorney who wish to participate in the 58th AGM, please refer to the following procedures for using the RPV facilities:

Procedure	Action
Prior to the day of 58th AGM	
1. Register as a user with TIIH Online	<ul style="list-style-type: none"> Using your computer or smartphone, access the website at https://tiih.online. Register as a user under the “e-Services”, select the “Sign Up” button and followed by “Create Account by Individual Holder”. For corporate or institutional shareholders, please refer to the registration procedures in Section D below. Please refer to the tutorial guide posted on the homepage for assistance. Registration as a user will be approved within one (1) or two (2) working days and you will be notified via e-mail. If you are already a user with TIIH Online, you are not required to register again. You will receive an email to notify you that you can now register online via TIIH Online to attend the 58th AGM.
2. Submit your request	<ul style="list-style-type: none"> Registration is open from Monday, 30 September 2024 until the day of the 58th AGM on Tuesday, 29 October 2024. Shareholder/proxy/authorised representative/attorney are required to pre-register their attendance for the 58th AGM to ascertain their eligibility to participate the 58th AGM using the RPV facilities. Login to TIIH Online at https://tiih.online with your user ID and password and select the corporate event: “(REGISTRATION) ANCOM LOGISTICS BERHAD 58th AGM”. Read and agree to the Terms & Conditions and confirm the Declaration. Select “Register for Remote Participation and Voting”. Review your registration and proceed to register. You will receive an email to notify that your registration for the RPV facilities is received and will be verified. After verification of your registration against the Record of Depositors as at 21 October 2024, you will receive an email on or after 27 October 2024 to approve or reject your registration for the RPV facilities.
On the day of the 58th AGM	
3. Login to TIIH Online	<ul style="list-style-type: none"> Login to TIIH Online at https://tiih.online with your user ID and password for the RPV facilities to participate at the 58th AGM at any time from 10.00 a.m. i.e. one (1) hour before the commencement of the 58th AGM on Tuesday, 29 October 2024 at 11.00 a.m.
4. Participate through live streaming	<ul style="list-style-type: none"> Select the corporate event: “(LIVE STREAMING MEETING) ANCOM LOGISTICS BERHAD 58th AGM” to engage in the proceedings of the AGM remotely. If you have any questions for the Chairman/Board of Directors, you may use the query box in the RPV facilities to type in your questions and to transmit your questions to the Chairman/Board of Directors.
5. Online remote voting	<ul style="list-style-type: none"> Voting will commence from 11.00 a.m. on Tuesday, 29 October 2024 until a time when the Chairman announces the completion of the voting session of the 58th AGM. Select the corporate event: “(REMOTE VOTING) ANCOM LOGISTICS BERHAD 58th AGM”. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your vote for the resolutions tabled for voting. Confirm and submit your vote.

On the day of the 58th AGM (cont'd)		
6.	End of remote participation and voting	Upon the announcement to be made by the Chairman on the closure of the 58 th AGM, the live streaming will end.

Notes to the RPV facilities users:

- (i) Should your application to join the 58th AGM be approved, the system will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the 58th AGM will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the Internet connection at your location and the device you use.

D. APPOINTMENT OF PROXY(IES)

The AGM will be conducted entirely by live streaming from the Broadcast Venue. If you are unable to participate, speak and vote at the 58th AGM via the RPV facilities on Tuesday, 29 October 2024, you may appoint a proxy or not more than two (2) proxies or the Chairman of the Meeting as your proxy(ies) to attend the 58th AGM on your behalf.

You may submit your Proxy Form to Tricor's office or electronically as mentioned in Section B above no later than **Sunday, 27 October 2024 at 11.00 a.m.**, otherwise your Proxy Form shall not be treated as valid.

You may also submit the Proxy Form by electronic means via TIIH Online website at <https://tiih.online> no later than **Sunday, 27 October 2024 at 11.00 a.m.**. Please do read and follow the procedures below to submit the Proxy Form by electronic means.

SUBMISSION OF PROXY FORM BY ELECTRONIC MEANS

The procedures to submit your Proxy Form by electronic means via TIIH Online website are summarized below:

Proceed with submission of Proxy Form	<ul style="list-style-type: none"> • After the release of the Notice of 58th AGM by the Company, login to TIIH Online at https://tiih.online with your user ID and password. • Select the corporate event: “ANCOM LOGISTICS BERHAD 58th AGM – SUBMISSION OF PROXY FORM”. • Read and agree to the Terms & Conditions and confirm the Declaration. • Insert your CDS account number and indicate the number of shares for your proxy to vote on your behalf. • Appoint your proxy and insert the required details of your proxy or appoint the Chairman as your proxy. • Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote at his/her discretion. • Review and confirm your proxy appointment. • Print Proxy Form for your record.
For Corporate or Institutional Shareholders		
1.	Register as a user with TIIH Online	<ul style="list-style-type: none"> • Using your computer or smartphone, access TIIH Online at https://tiih.online. • Register as a user under the “e-Services”, select the “Sign Up” button and followed by “Create Account by Representative of Corporate Holder”. • Complete the registration form and upload the required documents. • Registration will be verified, and you will be notified by email within one (1) to two (2) working days. • Proceed to activate your account with the temporary password given in the email and re-set your own password. <p><i>Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can proceed with submission of Proxy Form mentioned in 2 below. Please contact the Tricor’s representatives named in Section G below if you need clarifications on the user registration.</i></p>
2.	Proceed with submission of Proxy Form	<ul style="list-style-type: none"> • After the release of the Notice of 58th AGM by the Company, login to TIIH Online at https://tiih.online with your user ID and password. • Select the corporate event: “ANCOM LOGISTICS BERHAD 58th AGM – SUBMISSION OF PROXY FORM”. • Read and agree to the Terms & Conditions and Declaration. • Proceed to download the file format for “Submission of Proxy Form” in accordance with the Guidance Note set therein. • Prepare the file for the appointment of proxy by inserting the required data. • Log in again to TIIH Online at https://tiih.online, select the corporate event “ANCOM LOGISTICS BERHAD 58th AGM – SUBMISSION OF PROXY FORM”. • Proceed to upload the duly completed proxy appointment file. • Select “Submit” to complete your submission. • Print the confirmation report of your submission for your record.

Proxy/authorised representative/attorney who wishes to participate, speak and vote in the 58th AGM via the RPV facilities must first register himself/herself for the RPV facilities at TIIH Online website at <https://tiih.online>. Please refer to the procedures for using the RPV facilities stated in Section C above.

E. POLL VOTING

Pursuant to Paragraph 8.31A of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad, all the resolutions set out in the Notice of 58th AGM will be put to vote by poll.

Shareholders can proceed to vote on the resolutions at any time from the commencement of the 58th AGM until the end of the voting session which will be announced by the Chairman of the Meeting.

Upon completion of the voting session for the 58th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

F. NO RECORDING/PHOTOGRAPHY

Unauthorised recording and taking photographs of the proceedings at the 58th AGM is strictly prohibited.

G. DOOR GIFT

In the event the Company decides to provide a door gift to the registered shareholder who attends the 58th AGM via the RPV facilities, please note that only the registered shareholders who hold not less than 1,000 shares and who have stayed through the proceedings of the AGM will be entitled to a door gift which will be announced by the Chairman in the Meeting. If the registered shareholders who have appointed proxy(ies) to attend the meeting and the proxy(ies) has/have stayed through the proceeding of the 58th AGM, only the registered shareholders will receive the door gift.
