## A. MODE OF MEETING

The 58<sup>th</sup> AGM will be conducted entirely through live streaming using the remote participation and voting ("**RPV**") facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("**Tricor**") via TIIH Online website at <u>https://tiih.online</u>. Shareholders are to participate, speak (via real time submission of typed texts only) and vote remotely using the RPV facilities.

Pursuant to Section 327(2) of the Companies Act 2016, the Chairman shall be present at the Broadcast Venue to chair the 58<sup>th</sup> AGM. Shareholders will not be allowed to attend the 58<sup>th</sup> AGM in person at the Broadcast Venue on the day of the Meeting.

## B. APPOINTMENT OF PROXY/AUTHORISED REPRESENTATIVE/ATTORNEY

If you wish to appoint proxy to participate and vote at the 58<sup>th</sup> AGM on your behalf, you must ensure that the duly executed Proxy Form is deposited either in a hard copy form at Tricor's office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or at its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or by electronic means via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> no later than **Sunday, 27 October 2024 at 11.00 a.m.** (Please refer to the Procedures in Section D below).

Authorised representative of corporate member must deposit the ORIGINAL Certificate of Appointment of Authorised Representative at Tricor's office on or before the time appointed for holding the 58<sup>th</sup> AGM for the appointment to be valid for the purposes of attending the 58<sup>th</sup> AGM.

For an attorney appointed via a Power of Attorney, the Power of Attorney or a notarially certified copy of such Power of Attorney must be deposited at Tricor's office at the address above or by electronic means via TIIH Online website at <u>https://tiih.online</u> not later than **Sunday, 27 October 2024 at 11.00 a.m.** for the appointment to be valid for the purposes of attending the 58<sup>th</sup> AGM.

# C. PROCEDURES FOR USING THE RPV FACILITIES

Only shareholders whose name appears in the Record of Depositors as at **21 October 2024** shall be entitled to participate, speak and vote at the 58<sup>th</sup> AGM or to appoint proxy, authorised representative or attorney, as the case maybe, to participate, speak and vote on their behalf at the 58<sup>th</sup> AGM.

For shareholder/proxy/authorised representative/attorney who wish to participate in the 58<sup>th</sup> AGM, please refer to the following procedures for using the RPV facilities:

Notes to the RPV facilities users:

- (i) Should your application to join the 58<sup>th</sup> AGM be approved, the system will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the 58<sup>th</sup> AGM will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the Internet connection at your location and the device you use.

# D. APPOINTMENT OF PROXY(IES)

The AGM will be conducted entirely by live streaming from the Broadcast Venue. If you are unable to participate, speak and vote at the 58<sup>th</sup> AGM via the RPV facilities on Tuesday, 29 October 2024, you may appoint a proxy or not more than two (2) proxies or the Chairman of the Meeting as your proxy(ies) to attend the 58<sup>th</sup> AGM on your behalf.

You may submit your Proxy Form to Tricor's office or electronically as mentioned in Section B above no later than **Sunday**, **27 October 2024 at 11.00 a.m.**, otherwise your Proxy Form shall not be treated as valid.

You may also submit the Proxy Form by electronic means via TIIH Online website at <u>https://tiih.online</u> no later than **Sunday, 27 October 2024 at 11.00 a.m.**. Please do read and follow the procedures below to submit the Proxy Form by electronic means.

Proxy/authorised representative/attorney who wishes to participate, speak and vote in the 58<sup>th</sup> AGM via the RPV facilities must first register himself/herself for the RPV facilities at TIIH Online website at <u>https://tiih.online</u>. Please refer to the procedures for using the RPV facilities stated in Section C above.

## E. POLL VOTING

Pursuant to Paragraph 8.31A of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad, all the resolutions set out in the Notice of 58<sup>th</sup> AGM will be put to vote by poll.

Shareholders can proceed to vote on the resolutions at any time from the commencement of the 58<sup>th</sup> AGM until the end of the voting session which will be announced by the Chairman of the Meeting.

Upon completion of the voting session for the 58<sup>th</sup> AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

#### F. NO RECORDING/PHOTOGRAPHY

Unauthorised recording and taking photographs of the proceedings at the 58<sup>th</sup> AGM is strictly prohibited.

#### G. DOOR GIFT

In the event the Company decides to provide a door gift to the registered shareholder who attends the 58<sup>th</sup> AGM via the RPV facilities, please note that only the registered shareholders who hold not less than 1,000 shares and who have stayed through the proceedings of the AGM will be entitled to a door gift which will be announced by the Chairman in the Meeting. If the registered shareholders who have appointed proxy(ies) to attend the meeting and the proxy(ies) has/have stayed through the proceeding of the 58<sup>th</sup> AGM, only the registered shareholders will receive the door gift.
